PROBLEM THIS PROJECT AIMS TO ADDRESS: The International Dysphagia Dic Standardisation Initiative (IDDSI) was founded in 2013 with the goal of developing neglobal standardized terminology and definitions to describe texture modified foods and thickened liquids used for individuals with dysphagia of all ages, in all care settings, an all cultures. Currently no skilled nursing facilities in Idaho have implemented IDDSI.	w ıd			

- b. <u>GOAL</u>: More safely serve residents in skilled nursing facilities and across the continuum, with dysphagia.
- c. <u>PLAN TO IMPLEMENT THE PROJECT</u>: The American Academy of Nutrition and Dietetics (AND) and the American Speech-Language-Hearing Association have voted to

formally support the implementation of IDDSI framework and definitions. Work is underway to develop an IDDSI implementation plan. IDDSI has already received reports from many organizations in the US and territories about IDDSI implementation process.

In December, 2017 members of the Idaho Academy of Nutrition and Dietetics (IAND) & American Speech-Language-Hearing Association (ASHA) formed a workgroup to begin discussing implementation & education on IDDSI across all provider types in Idaho. Consistency in transitions of care to various levels of care improves quality of care and outcomes. Therefore coordination of an IDDSI implementation plan is critical to success. May 1, 2019 has been identified as the launch date for IDDSI in the United States.

8. Describe how this project will directly benefit nursing home residents.

The International Dysphagia Diet Standardization Initiative project will directly benefit nursing home residents through the implementation of global standardized terminology and definitions for texture-modified foods and thickened liquids intended to improve the safety by all practitioners using the same diet names and definition; and care for individuals with dysphagia, a swallowing disorder, which affects an estimated 560 million people worldwide.

The International Dysphagia Diet Standardisation Initiative Framework has been accepted by the Academy of Nutrition & Dietetics and targeted for a May 1, 2019 implementation in the US. The Academy anticipates that the transition to the IDDSI framework will occur over the span of a few years. This transition will impact many areas of the profession and require multidisciplinary education & coordination across multidisciplinary practices.

IDDSI is an evidence-informed framework for texture modified food and thickened liquids developed by an international team through systematic review, multi-stakeholder surveys and review of existing national standards and common practice.

Example: A project may include funding for technical assistance, training, and consultation to nursing homes over a one-year period. Example outcome metrics include the following: At the end of the one-year period, the applicant organization had conducted 12 in-person trainings with 1,455 attendees. A satisfaction questionnaire found that 70% of attendees were very satisfied with the trainings they received, 15% were satisfied, 3% were unsure, 10% were dissatisfied, and 2% were very dissatisfied. Nursing homes who sent at least one staff member to the training saw an improvement in influenza immunization rates by 3 percent and pneumococcal immunizations rates by 10 percent.

Accessing key players.

Implementation of the IDDSI requires support from the administrative staff (administrator, director of nursing, therapy department, kitchen staff, activities staff, and medical director) of the facility. Without their support change will not occur.

Plan to address this concern is the drafting of seven (7) "regional teams" consisting of at a minimum, Speech Therapist & Registered Dietitian Nutritionist (possibly a CDM, CFPP). These teams would be tasked with visiting the nursing homes in their region and initiating the conversation of implementation of IDDSI and offer educational support.

<u>Idaho Speech-Language-Hearing Association (ISHA)</u> will not be receiving funding. ISHA will partner with IAND in providing education and implementation of the diet within their scope of practice.

<u>Idaho Association of Nutrition & Foodservice Professionals (I-ANFP)</u> will not be receiving funding. Members will be included in the education and implementation plan since the majority of their membership are the Nutrition Service Directors in Idaho's skilled nursing facilities.

<u>Idaho Medical Directors Association</u> will not be receiving funding but skilled nursing facility medical directors will be encouraged to attend as one of the scholarshipped disciplines recommended to attend the annual Conference Roundtable.

<u>Idaho Hospital Association</u> will not be receiving funding. Partner with their Education Director to provide training to appropriate disciplines on IDDSI. The dysphagia diet orders most generally begin during hospitalization. Hospital clinical, medical, and therapy staff need to be educated and on-board for implementation to be successful.

Idaho Educational Institutions with SLP, RD, & CDM programs.
